Torres AI CI implements Cyber Forensics Investigation and Intelligence Solutions for customers around the world including fully operational Cyber Investigative Units and Cyber Intelligence Units (CIUs). The CIUs we deliver cast wide and deep nets to collect critical web- and social media-based evidence and intelligence and is today's key law enforcement and intelligence cyber and digital resource needed to solve crimes and prevent threats to the safety and security of governments, armed forces, and civil society.

These CIUs routinely accelerate the investigation of serious crimes and the collection and analysis of intelligence against threats to national defense and security. The CIUs build cases and prosecute national and transnational *Criminal Cartels, Drug and Arms Traffickers, Human and Sex Traffickers, Terrorist Groups, Organized Gangs, Militants, Rebels, and Insurgents*, and routinely solve high crimes (felonies) such as homicide, money laundering, kidnapping, identity theft, hacking, and posting fake and false news on web sites and social media intended to harm and disrupt civil society.

The CIUs also have the capability to **attack and remove (Take Down) web and social media content** that pose threats to the safety of governments, armed forces, and civil society, and to conduct cyber-based countermeasure operations to refute fake and false news claims.

CIU - Force Multiplier for Law Enforcement and Intelligence Organizations

The CIUs of our customers are "**Force Multipliers**" with small footprints meaning that a small and dedicated unit of five (5) to ten (10) Cyber Forensics Analysts can accelerate the work conducted by entire investigative and intelligence units from periods of years to months and weeks to days. This is a **highly efficient and cost-effective way** to conduct investigations and intelligence operations. Examples:

- → Within two-weeks of implementing a CIU for a South American Police Force, the team rescued the wife of a Minister who had been kidnapped for over two-years.
- → Within nine-months of implementing a CIU for an African Police Force, the team prosecuted 48 high profile criminal cases including crimes that directly threatened the government and civil society.

- ★ Within one-month of implementing a CIU for a South American Police Force, the team solved a one of the largest money laundering crimes in the history of the nation and the region.
- Withing six-months of implementing a CIU for a South American Intelligence Unit, the team routinely interdicted and seized illegal drugs that were trafficked internationally and identified and arrested a faction of a South American Terrorist organization.

US Armed Forces – Information Operations and Atmospherics

Torres AI CI integrates Information Operations (IO) and Atmospherics into our Cyber Intelligence Systems and Methods to form a complete understanding of the digital operational environment. For example, we employ Information Operations to influence action among and between targets in order to identify and track their activities, movements and locations. We then employ Atmospherics to measure the impact of target activities and messaging among the people and populations within the areas of interest. With this information we can employ countermeasures to mitigate the bad intents of the targets.

Fully Operational CIU with Highly Trained Cyber Forensics Analysts in 60-Days

Our Cyber Teams deliver *fully operational CIUs with fully trained customer personnel within 60-Days* at prices that most investigative or intelligence agencies can afford. This means we deliver all cyber forensics hardware, software, database, and communication systems, and we train inexperienced customer personnel to become *Cyber Forensics Analysts*, *Supervisors and Managers* who operate at professional levels.

After our Cyber Team completes the CIU, we continue to provide cyber forensics investigative and intelligence support in actual cases and intelligence operations for a period of one-year. We remain in place until your CIU is highly proficient in Cyber Forensics; they successfully arrest criminals, prosecute crimes, and reduce threats to government and civil society.

Leading Architect in the Integration of AI into Cyber Forensics Systems and Methods
